Description

In this course, we will consider the views of philosophers who try to answer questions such as: What is the best form of political organization? Is the existence of the state a necessity? How can obedience to political authority be legitimized? What is justice? How is justice achieved? We will divide its history into five periods: the Ancient Period, the Middle Ages, the Modern Period, the Neo-Modern Period, and the Post-Modern Period. Polis was at the center of the ancient period political structure. Virtue was the primary ideal in political life, which is accepted as natural. It is seen that feudalism was the basis of the medieval period. In this period, the political emphasis shifted to the faith and theological interpretations came into existence. The modern period witnessed the emergence of the centralized nation-state. It became important to understand life and society with scientific methods. Issues such as security, freedom, property, representative democracy were the main topics of politics of the modern era. Throughout the course, we will consider historical developments and try to understand the atmosphere in which ideasemerged. However, the main emphasis will be on philosophical arguments and the universal aspects of thinkers.

The "grand dichotomy", which embodies the traditional on the one hand and the modern on the other, is at the heart of the modernization theorist's understanding of social change. These two concepts, similar to the two poles of an axis, correspond to the two extreme states of the modernization process. With reference to the great duality, the theory of modernization uses numerous explanatory dichotomies, economic, political, and cultural. This course will quantitatively investigate the processes of modernization at both the individual and social levels, looking at the practical elements of modernization, including socio-economic development, industrialization, urbanization and secularization. Before World War II, development was not an issue that the vast majority of decision makers around the world saw as a problem to be addressed. Even after a consensus emerged after World War II about the need to solve this problem, the ways it has been conceptualized, as well as the views on its causes and possible remedies, diverged greatly and evolved in time. Also, the view that development as a political project has failed and the time to move on a post-development age has started to become popular in some intellectual circles after the 1960's. As a more optimistic perspective, the agenda of sustainable development emerged. This course offers students a conceptual history of "development". We will then turn to an in-depth discussion of the basics of causal inference and the limitations of experimental and observational methods in the study of social phenomena, culminating in tutorials on the use of matching and linear



regression for causal inference. The course will then shift to a set of cutting
